Chapter 1

SYSTEM GUIDELINES

1-1. Executive Sponsor. The Executive Staff Director is identified as the Executive Sponsor for DCFTracker. The duties of the Executive Sponsor include:

- a. System oversight;
- b. Development of appropriate system guidance;
- c. Coordination of systems development, as needed;
- d. Implementation of appropriate Operating Procedures; and,
- e. DCFTracker Training.

1-2. Purpose. This chapter provides instructions for access, use and operation of the DCFTracker assignment management system. This operating procedure is designed to ensure effective collaborations, efficient management and accountability for correspondence, client complaints or requests, public records requests, and other assignments. This includes Assistant Secretaries, Headquarters Program Offices, Circuits, the Regions and Lead Agencies.

1-3. Scope. This operating procedure applies to all Department employees, Lead Agency employees and any others with access to the DCFTracker management tracking system.

1-5. Access.

a. DCFTracker is a web-based data system maintained by the Office of the Chief Information Officer. As such, access to DCFTracker is available to Department and Community-Based Care (CBC) Lead Agency employees to perform their assigned duties.

- b. DCFTracker requires that users have an LDAP userid.

Chapter 2

SYSTEM ACCESS

2-1. Purpose. This chapter describes the procedure for accessing DCFTTracker.

2-2. New Users. DCFTTracker is available to all Department staff. Unless Executive Staff specifically authorizes exceptions, staff is assigned to the General role in Tivoli Identity Manager (TIM). To gain access to DCFTTracker:

- a. User contacts their DCFTTracker Administrator.
- b. DCFTTracker Administrator:
 - (1) Contacts the Statewide Help Desk requesting access to DCFTTracker for their staff member.
 - (2) Creates a new User record in DCFTTracker.
 - (3) Attaches user to the appropriate DCFTTracker Functional Area.
- c. The Help Desk issues an Incident Management Ticket to the Regional Security Officer.
- d. The Regional Security Officer processes the Help Desk ticket:
 - (1) Determines preexisting LDAP (Lightweight Directory Access Protocol) account.
 - (a) Establishes new LDAP account if none exists; or,
 - (b) Contacts user to request any needed information.
 - (2) Sets LDAP Group Attribute to DCFTTracker in Tivoli Identity Manager (TIM).
- e. Once the Regional Security Officer completes the request in TIM, the Regional Security Officer sends the user an email with their userid and a link to their password.
- f. The Regional Security Officer closes the Helpdesk Incident Management Ticket.
- g. ServiceCenter sends the DCFTTracker Administrator and the user an email stating that the request is complete. This email will contain a link to log onto DCF Web Systems Portal. The user can download the DCF Web Systems Portal User Guide on this site.

NOTE: System security requires correct users' email addresses in TIM for system access. Current users needing to identify or reset their passwords should contact the DCF HelpDesk by calling (850) 487-9400 or through email at DCF_HELPDESK/D20/DCF.

Chapter 3

FUNCTIONAL AREAS

3-1. Purpose. This chapter establishes the procedures for establishing Functional Areas.

3-2. Functional Areas. DCFTTracker Functional Areas are the foundation of the DCFTTracker workflow and correspond to Department work units following the Department's Organizational Chart. All DCFTTracker users must be in a Functional Area to access and use the system.

- a. DCFTTracker Administrators manage membership within Functional Areas.
- b. The following example demonstrates the naming convention used by DCFTTracker.

Example:

Work Unit: Circuit 1

Functional Area: ...C01

3-3. Auxiliary User. DCFTTracker Administrators can designate users as an Auxiliary User Type within a Functional Area.

- a. Auxiliary Users do not receive the automatically generated notifications relating to DCFTTracker.
- b. All members of the Functional Area are able to access DCFTTracker.

3-4. New Functional Areas. The DCFTTracker Administrator is the central point of contact for requesting the creation of new Functional Areas. Only the DCFTTracker Administrator should make the request.

- a. The standard naming format for Functional Areas are based on Headquarters office symbols and Region or Circuit designations as listed in CFOP 15-1.
- b. Functional Areas will identify within DCFTTracker their supervising Functional Area.
- c. The DCFTTracker Administrator requests the DCFTTracker Authorization Group, consisting of the Executive Staff Director, and the DCFTTracker Administrator, to create a new Functional Area. DCFTTracker Authorization Group ensures the Functional Area conforms to DCFTTracker naming conventions.
- d. After review and approval, the DCFTTracker Administrator creates the Functional Area.
- e. The DCFTTracker Authorization Group adds the new Functional Area to DCFTTracker and notifies the requesting DCFTTracker Administrator that the new Functional Area was added to DCFTTracker.

3-5. DCFTTracker Administrator. Each Assistant Secretary, Program Director, Regional Director, and Circuit Administrator will designate one staff member to serve as the DCFTTracker Administrator for the Functional Area.

- a. The DCFT Administrator acts as the central point of contact for all DCFT matters. It is the responsibility of the DCFTTracker Administrator to manage DCFTTracker Functional Areas' members.

b. The DCFTTracker Administrator also maintains the authority for requesting the creation of new Functional Areas by contacting the DCFTTracker Authorization Group (using email address DCFTTracker_Authorization_Group).

c. The DCFTTracker Administrator is responsible for addressing a variety of matters relating to DCFTTracker including:

- (1) Users' questions;
- (2) Secretary's correspondence (system or technical questions, not writing or assignment questions);
- (3) Training requests;
- (4) System feedback;
- (5) Proposed enhancements; and,
- (6) Distributing information.

d. Each Assistant Secretary, Headquarters Program Office, Circuit and Region is responsible for ensuring that the DCFTTracker Authorization Group is notified when their DCFTTracker Administrator changes.

3-6. Functional Area Updates. DCFTTracker Administrators are responsible for maintaining existing Functional Areas. The DCFTTracker Administrators edit members by using the User Management module within DCFTTracker.

3-7. Functional Area Referral. Following normal correspondence procedures, Functional Areas may refer Issues to other Functional Areas. They may also refer work to their subordinate Functional Areas following the Department's Organizational Chart.

a. Functional Areas refer Issues to other Functional Areas or to subordinate Functional Areas.

b. For example, the Functional Area "AS", Assistant Secretary for Administration, may refer work to Functional Areas "OSGC", General Counsel; or "PDES", Assistant Secretary for Economic Self-Sufficiency. AS may also delegate work to a Functional Area reporting to AS, such as "ASFM", Chief Financial Officer.

Chapter 4

STATEWIDE SECURITY OFFICER RESPONSIBILITIES

4-1. DCFTTracker Security Guide. The DCFTTracker Security Guide describes the Regional Security Officers' role and, secondarily, the Statewide Help Desk's role in DCFTTracker user management.

4-2. System Security.

a. DCFTTracker is accessed through the DCF Web Systems Portal.

b. The Tivoli Identity Manager (TIM) exists for Information Technology management of user access. Tivoli Identity Manager is the Department's central point of registration for all our computer system users. Data Security manages TIM.

4-3. LDAP Security Roles. There are currently three (3) security roles available in the LDAP Group Attribute for DCFTracker within Tivoli Identity Manager: 'GENERAL', 'OIG' and 'ADMIN'.

4-4. Systems Rights. Security Officers are responsible for ensuring that the appropriate rights are made available to those with the specific responsibility to maintain Tivoli Identify Manager (TIM).

The DCFTTracker Administrator sends the request by email to the DCFTTracker Authorization Group.

The text for the email should read as listed below. The required elements for the request are:

The proposed name for the Functional Area; and,
A Description using the office name;

Update a Functional Area

DCFTTracker Administrators are responsible for maintaining Functional Area members. This includes all Functional Areas established under them on the Department's Organizational Chart.

DCFTTracker Administrators are responsible for maintaining existing Functional Areas. The DCFTTracker Administrators edit members by using the User Management module within DCFTTracker.

All DCFTTracker Administrators are authorized to edit their Functional Areas accordingly.
